

MP Dalit teen killed by men accused by his sister of harassment

AN 18-YEAR-OLD Dalit man from Madhya Pradesh's Sagar district was beaten to death, allegedly by men who had been mounting pressure on him to convince his sister to withdraw a sexual harass-

ment case she filed in 2019, police said. The incident sparked a bitter political slugfest, with the Congress pointing to an "atmosphere of fear", and the BJP accusing it of "politicising the matter". According to police, the accused beat the 18-year-old to death with sticks and then damaged portions of his family's house.

The incident took place on Thursday. Sagar Additional Superintendent of Police Lokesh Kumar said an FIR was registered under section 302 (murder) of the IPC. "A search for the accused is underway. A few of the accused have been taken into custody and further action is being taken," he said. Six people have been arrested

so far, while several others are absconding. According to police, the victim's sister had in 2019 filed a sexual harassment case against some of the accused, who turned up at the victim's house on Thursday and urged her and her mother to withdraw the case. When they did not relent, the accused left the house and found

the 18-year-old near a bus stand. They allegedly confronted him and began assaulting him with sticks, police said. The mother and the sister ran to the bus stand and pleaded with the assailants to stop, but they continued the assault, the family said. FULL REPORT ON www.indianexpress.com

'CYLINDER WAS ILLEGALLY BROUGHT INSIDE' 9 from UP killed as gas cylinder triggers fire in stationary train coach in Madurai

NINE PEOPLE from Uttar Pradesh died after a fire broke out inside a train coach parked near Madurai railway station in the early hours of Saturday. According to officials, the fire was triggered by a gas cylinder that passengers had "illegally" brought inside the privately hired coach to "prepare tea and snacks". The coach was part of a private tour package that started its journey from Lucknow on August 17, and was scheduled to return on August 29.

It had been attached to various trains en route to several tourist destinations. A total of 55 tourists, and eight support staff from the tour operator, were on board the coach. Madurai District Collector M S Sangeetha told The Indian Express that apart from those who died, seven others sustained minor injuries in the accident and were given treatment at the Government Rajaji Hospital as well as at the Railway Hospital.

"A total of nine people - includes six male passengers and three female passengers - were killed in the fire accident. All of them are aged above 50 years," the collector said. Officials said eight of the nine victims were identified.

Fire and Rescue Services Department deputy director Vijay Kumar said the department received a call regarding the fire at 5.45 am and that fire tenders rushed to the spot immediately. They, however, had initially faced some difficulty in reaching the coach due to the high compound walls surrounding the area where it was parked. According to the Railway Divisional Manager's office, the coach's doors being locked

from the inside had made the situation worse. "Additional padlocks had trapped passengers inside. The passengers had to break open the locks themselves. By that time, some had already suffered severe burns," an official said. District Collector Sangeetha said, "Since they (the passengers) thought that the train had stopped midway in some unknown area, they locked their coach from the inside using locks that they had brought. Soon after the fire broke out, the passengers were not able to get out of the coach because it was locked and they didn't know who had the key at that moment. Later, they broke open the door and jumped from the coach."

The Southern Railway's preliminary investigation revealed that inside the coach, which was parked at the time of the incident, some members of the private touring party used "illegally smuggled cooking gas cylinder for preparing tea or snacks", and that this caused the fire.

P Moorthi, Tamil Nadu minister for Commercial Taxes, said the incident brought to the fore concerns regarding laxity in adhering

to safety norms, particularly in privately booked coaches. "This incident raises questions about the efficacy of checks on carrying inflammable materials, especially in such private coaches, which can be booked online through the IRCTC portal," he said. Any individual can book a private party coach using the IRCTC portal. However, passengers are not allowed to carry inflammable objects such as gas cylinders on board the coach. In an official statement, Southern Railway said, "This is a private party coach that was attached at Nagercoil Junction on Friday by Punalur-Madurai Express, which arrived at Madurai at 3.47 am. [The] party coach was detached and kept at the Madurai stabling line. The passengers have illegally smuggled gas cylinder and this has caused the fire." President Droupadi Murmu expressed her condolences to the families of the dead and wished the injured a speedy recovery.

Chief Minister M K Stalin announced ex-gratia of Rs 3 lakh to the families of the deceased, in addition to Rs 10 lakh that the Railways had already declared.
